REVISED RECOGNITION ORDER

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, the Institution, "Sh. Rameshwar Lal Sharma Teacher Training College Kajra, Plot No-16, Village- Kajra, Post Office- Kajra, Tehsil/Taluka-Surajgarh, Town/City- Kajra, District-Jhunjhunun, State-Rajasthan, Pin Code-333030" had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for B.A.,B.Ed./ B.Sc.,B.Ed. Integrated on dt. 16.11.2016 with an intake of 50 students.

2. AND, WHEREAS, on scrutiny/perusal, veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the inputs received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against the decision of clause 7(13) of the NCTE Regulations, 2014 (earlier 7(9) of the NCTE Regulations, 2009), the Northern Regional Committee in its 253rd (Part-1) meeting held from 30th May to 03rd June, 2016, being satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standard for the concerned Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms and as per the approval of faculty given by the affiliating body, granted recognition for B.A. B.Ed/ B.Sc. B.Ed. Integrated course of four years duration with an annual intake of 50 (1 unit) from the academic session 2017-2018 under Clause 7(16) of NCTE (Recognition Norms & procedure) Regulations, 2014. Accordingly order was issued to the institution vide no. F.NRC/NCTE/NRCAPP-15330/253rd (Part-1) meeting/2016/162166-71 dated 16.11.2016 for B.A.,B.Ed./ B.Sc.,B.Ed. Integrated with an intake of 1 unit of 50 students.

3. AND WHEREAS, the institution preferred an appeal dt. 29.05.2017 before the Council, NCTE Hqrs. New Delhi under section 18 of the NCTE Act, 1993 for grant of recognition for two units (100 students).

4. AND WHEREAS, the order passed by the Appellate Authority of NCTE, New Delhi vide No. F.No. 89-61/2017 Appeal/8th Meeting-2017/54298 dt. 29.05.2017 was placed before the NRC in its 272nd meeting of NRC, NCTE held from 06th to 07th July, 2017. The Committee decided that as per the directions of the Appeal Committee, order be Issued to the institution for B.A.B.Ed./B.Sc.B.Ed. Integrated course.

5. NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a)/15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to the institution for additional 50 students (1 unit), making the total intake of 100 students (B.A. B.Ed. -50, B.Sc. B.Ed.-50) from the academic session 2018-2019.

6. AND, WHEREAS, the other contents of the Recognition Order no. F.NRC/NCTE/NRCAPP-15330/253rd (Part-1) meeting/2016/162166-71 dated 16.11.2016 shall remain unchanged.
